Singapore is a well-regulated, cost effective and internationally recognized jurisdiction to manage and administer international private equity funds, especially those with an African or Asian investment focus.

Under the Securities and Futures Act (“SFA”), companies wishing to engage in the business of fund management in Singapore are either a licensed fund management company (“LFMC”) holding a Capital Markets Services (“CMS”) licence in fund management, or a registered fund management company (“RFMC”) with the Monetary Authority of Singapore (“MAS”).

In particular, Singapore is certainly a jurisdiction at the forefront of change in the global fund space. On January 15, 2020, the Monetary Authority of Singapore (MAS) and the Accounting and Corporate Regulatory Authority (ACRA) launched the Variable Capital Company (VCC), a new corporate entity structure for all types of funds in the jurisdiction, namely the Variable Capital Company (“VCC”) in Singapore.
